CANCELLATION POLICY FOR COUNTY OFFICIALS

- <u>Early Cancellation</u>: If notice of cancellation is received from date of registration to **September 14**, **2022**, no cancellation fee will be assessed.
- <u>25% Cancellation Fee</u>: If notice of cancellation is received *September 15 October 3, 2022*, a cancellation fee equal to <u>twenty-five percent</u> (1/4) of the registration cost will be assessed, based on original registration fee.
- <u>50% Cancellation Fee</u>: If notice of cancellation is received *October 4 October 17, 2022*, a cancellation fee equal to <u>fifty percent</u> (1/2) of the registration cost will be assessed, based on original registration fee.
- 100% Cancellation Fee/No Show Fee: If notice of cancellation is received after October 18, 2022 or
 you do not check in at the MAS registration to receive your badge, a cancellation fee equal to one
 hundred percent of the registration cost will be assessed, based on original registration fee.
