14-Day Cancellation: If notice of cancellation is received **Dec. 16-31, 2018**, a cancellation fee equal to **25%** (\$50-\$62.50) of the registration cost will be assessed, based on original registration fee.

Late Cancellation/No-Show: If notice of cancellation is received **after Dec. 31, 2018** or is a “no-show,” a cancellation fee equal to **50%** (\$100-\$125) of the registration cost will be assessed, based on original registration fee. Refunds will only be issued after close of the conference.
