Contested Elections Resolved

Both the House and Senate chamber resolved the election challenges of Melanie Sojourner v. Bob Dearing and Blaine "Bo" Eaton v. Mark Tullos. The Senate chamber voted to seat Bob Dearing for Senate District 37 (Adams, Amite, Franklin, & Pike counties). The House chamber voted to seat Mark Tullos for House District 79 (Jasper and Smith counties).

Governor Bryant Orders Budget Cuts

Gov. Bryant is cutting \$39.8 million in spending and taking \$35.2 million from the rainy day fund to cover the revenue shortfalls. Most state agencies will face 1.5 percent cuts for the last half of the fiscal year that ends in June. By law, Gov. Bryant can make discretionary cuts up to 5 percent, but can't cut any agency or department by more than 5 percent until all have been cut by 5 percent. The state's sales tax collections have been particularly weak, and roughly \$350 million in tax cuts and credits for businesses or developments has affected State revenue. A phased-in reduction in the business inventory tax is reducing revenue for the coming year by \$126 million.
