**CANCELLATION & REFUND POLICY:** Written notice of cancellation must be received at the MAS Office no later than <u>December 5, 2022</u> for a refund consideration. Cancellations and refund requests are subject to a \$150 service charge. All registrations forms submitted but not cancelled by the deadline will be due in full regardless of if you have prepaid or not before the December 5, 2022 deadline. No refunds will be issued for cancellations received after <u>December 5, 2022</u>. No shows will still be due in full regardless of if you have prepaid or not before the close of Fall Workshop.

All Premier Sponsorships include company logo featured on event materials, in program, and listing in follow up magazine. We must receive all event material by <u>December 14, 2022</u> in order to allow sufficient time for planning and printing.

### FAQ's:

Question: Which page do I submit to be a sponsor?

Answer: Page 3 will need to be sent to MAS with the selected Sponsorship and attendee's information.

Question: Which page do I submit if I am attending with no sponsorship?

Answer: Page 4 will need to be sent to MAS with the rate selected and the attendee's information.

Question: Can I purchase a vendor table without a sponsorship?

Answer: <u>No</u>, you must purchase a Gold or Premiere Sponsor to add a table.

Question: Can I split the cost of a Premier Sponsorship with a fellow vendor?

Answer: <u>Yes</u>, cost may be split with another vendor. Benefits will also be split (*i.e. number of attendee passes*)

Question: Can MAS add more rooms to the hotel blocks at the initial booking rates?

Answer: <u>No</u>, once the room blocks are full, we cannot add additional rooms.

Question: If I cancel by December 5, 2022 will I receive a refund?

Answer: <u>Yes</u>, you have until December 5, 2022 to provide a written cancellation request minus service charge.

Question: If I cancel after December 5, 2022 will I receive a refund?

Answer: No, refunds will be issued for cancellations received after December 5, 2022.

Question: When will I receive an invoice?

Answer: After MAS processes your registration form and/or after the Meeting.
