Re: 2020 Annual Convention – **NEW DATES/Hotel Reservations Information**

As announced last week, because of the continuing COVID-19 crisis, on April 8, 2020 the MAS Board of Directors voted to reschedule the 91<sup>st</sup> Annual Convention to August 10-13, 2020. This decision was not taken lightly and was made in the best interest of our membership.

### **PLEASE READ THE FOLLOWING CAREFULLY!!**

**Hotel Reservations:** Each of the block hotels are handling existing reservations differently. If you have already made reservations for June dates, please see below for instructions on how to change/make new hotel reservations. Contact information for all hotels is listed on the County Registration Form.

June block dates (old): June 14-19, 2020

August Block dates (new): August 9-14, 2020

***Block rates for all hotels will be effective May 1, 2020 at 9:00 a.m.***

**Beau Rivage:** All existing reservations for June dates have been **cancelled** by the hotel. You must contact the Beau Rivage to make a new reservation under the August block.

**South Beach Hotel:** All existing reservations for June dates are on hold. You must contact South Beach to reschedule your reservation to the August dates or cancel. South Beach will not make any changes to your reservation until you contact the hotel, which means you will be responsible for the June dates unless you cancel.

**White House Hotel:** Existing reservations booked at the White House have been moved to the August block. You should have received an updated confirmation email. If you would like to change or cancel your reservation, please contact the hotel.

**Margaritaville:** Existing reservations booked before April 9 have been moved to the new August block. If you would like to change or cancel your reservation, please contact the hotel.

**Golden Nugget:** Existing reservations booked at the Golden Nugget have been moved to the August block. If you would like to change or cancel your reservation, please contact the hotel.

**Doubletree Hilton:** Existing Reservations made at the Doubletree Hilton have been moved to the August block. If you would like to change or cancel your reservation, please contact the hotel.

**IP Casino:** Existing reservations made at the IP Casino prior to April 10 have been moved to the August block. If you would like to change or cancel your reservation, please contact the hotel.

**Hard Rock Hotel:** The Hard Rock is currently closed and will not reopen until May 1. MAS staff have contacted the hotel to arrange a new block for August. Once arrangements have been finalized, MAS will notify counties on how to change/make new reservations for the August dates.
