### **CANCELLATION POLICY FOR COUNTY OFFICIALS**

Due to hotel attrition policies and catering deadlines, MAS has adopted the following cancellation fee schedule.

- <u>Early Cancellation</u>: If notice of cancellation is received from date of registration to *May 14, 2020*, no cancellation fee will be assessed.
- <u>14-Day Cancellation</u>: If notice of cancellation is received *May 15 29, 2020*, a cancellation fee equal to <u>one-fourth (1/4)</u> of the registration cost will be assessed, based on original registration fee.
- <u>Late Cancellation</u>: If notice of cancellation is received *after May 29, 2020*, a cancellation fee equal to **one-half (1/2)** of the registration cost will be assessed, based on original registration fee.
