CANCELLATION POLICY FOR COUNTY OFFICIALS

Due to hotel attrition policies and catering deadlines, MAS has adopted the following cancellation fee schedule.

- <u>Early Cancellation</u>: If notice of cancellation is received from date of registration to *July 11, 2020*, no cancellation fee will be assessed.
- <u>14-Day Cancellation</u>: If notice of cancellation is received *July 11 26, 2020*, a cancellation fee equal to <u>one-fourth (1/4)</u> of the registration cost will be assessed, based on original registration fee.
- <u>Late Cancellation</u>: If notice of cancellation is received *after July 26, 2020*, a cancellation fee equal to <u>one-half (1/2)</u> of the registration cost will be assessed, based on original registration fee.
- **COVID-19:** Regardless of cancellation policy stated above, if the 2020 COVID-19 crisis necessitates the cancellation of the 2020 Convention, MAS will refund all paid registration fees.
