## CANCELLATION POLICY FOR COUNTY OFFICIALS

Due to hotel attrition policies and catering deadlines, MAS has adopted the following cancellation fee schedule.

- **Early Cancellation:** If notice of cancellation is received from date of registration to **July 11, 2020**, no cancellation fee will be assessed.
- **14-Day Cancellation:** If notice of cancellation is received **July 11 – 26, 2020**, a cancellation fee equal to **one-fourth (1/4)** of the registration cost will be assessed, based on original registration fee.
- **Late Cancellation:** If notice of cancellation is received **after July 26, 2020**, a cancellation fee equal to **one-half (1/2)** of the registration cost will be assessed, based on original registration fee.
- **COVID-19:** Regardless of cancellation policy stated above, if the 2020 COVID-19 crisis necessitates the cancellation of the 2020 Convention, MAS will refund all paid registration fees.
