THE 2021 REGULAR LEGISLATIVE SESSION

IMPORTANT MAS BILLS SIGNED BY THE GOVERNOR

(The following bills were signed by the Governor)

<u>Senate Bill 2189:</u> This measure allows counties & cities the discretion to offer their Medicare eligible employees the option to transition from the county health benefits over to Medicare.

<u>Senate Bill 2336:</u> This measure delays the mandated implementation of the First Responder Health and Safety Act until year 2023. Without the delay, or state funding, counties and cities will be soon faced with an expensive unfunded mandate.

House Bill 74: This measure extends the repealer for the Emergency 911 Operation Code Section.

WEIGHT LIMIT BILL HEADS TO CONFERENCE, SENATE CHAMBER NAME CONFEREES (SENATE BILL 2825)

On Tuesday, March 16th, <u>Senate Bill 2825</u> was declined concurrence and invited for conferencing. **NOTE:** The current status of this measure will increase the weight limit of the harvest permit from 84k pounds to 88k pounds <u>with NO additional revenue</u>. Please contact your House and Senate delegation and request that they oppose any weight limit increase without continuous long-term revenue attached to it.

RURAL FIRE TRUCK FUNDING MEASURE IS IN CONFERENCE, SENATE CHAMBER NAME CONFERES (SENATE BILL 2602)

On Tuesday, March 16^{th} , <u>Senate Bill 2602</u> was declined concurrence and invited for conferencing. This measure provides \$5 million for rural fire truck funding.

CALLS STILL NEEDED

HOMESTEAD EXEMPTION REIMBURSEMENT (SENATE BILL 2923)

Section 8 of this measure, *Senate Bill 2923*, makes an appropriation of \$77,038,135.00. This line-item appropriation represents a \$1.9 million **cut** from last year's appropriation of \$79,013,472.00. Counties need an appropriation of \$88.7 million to be fully reimbursed. Please contact your local HOUSE delegation and ask that the homestead exemption be fully funded at \$88.7 million. (**NOTE:** This measure is now headed to conference.)
