Weekly Legislative Update 2018 Regular Legislative Session February 16, 2018

INFRASTRUCTURE REMAINS BIG TOPIC AT THE MS STATE CAPITOL

As we reach the half way mark of the 2018 Regular Legislative Session, conversations about infrastructure funding continues to intensify. The Senate has until February 27^{th} to consider <u>House Bill 722</u> that passed the MS House of Representatives 118 to 0. As a reminder, House Bill 722 diverts 35% of the use tax to counties (15%), cities (15%), and MDA (5%). This revenue would be residual coming in on an annual basis without approval from the Legislature. If passed, counties would receive \$46.5 million this year.

Please contact your local Senate delegation and ask that they strongly consider this legislation. In addition, it is rumored that the MS Senate will reveal its infrastructure plan either Monday or Tuesday of next week. MAS is monitoring this closely. We will provide immediate feedback if a plan is revealed.

HOMESTEAD EXEMPTION REIMBURSEMENT REDUCED

On Wednesday February 14, 2018, the Senate chamber passed <u>Senate Bill 2963</u>. Senate Bill 2963 is the appropriation for the Department of Revenue. In section 8 of this bill, the reimbursement for the homestead exemption is funded at \$79,424,665.00. Last year the homestead exemption reimbursement was funded at \$80,625,992.00. <u>Senate Bill 2963 currently presents a (\$1,201,327.00) reduction from last years appropriation</u>.

Please contact your local legislative delegation and request not to cut the homestead exemption reimbursement and increase to full funding level of \$87.5 million.

REVERSE AUCTION: House BILL 1131

Changes were made to <u>House Bill 1131</u> that would allow a governing authority to determine that if reverse auction is "not" in the best interest of the governing authority they may explain in their minutes why they did not utilize reverse auction instead of having to request an exemption from the Public Procurement Review Board (PPRB). For those counties that believe reverse auction is not in the best interest of their county, contact your local Senate delegation and askthat they support House Bill 1131. **NOTE:** <u>House Bill 1131</u> has passed the House Chamber and will head to the Senate for further discussion

RURAL FIRE TRUCK FUNDING LOCATED IN TWO HOUSE BILL

Funding for Rural Fire Truck can be found in <u>House Bill 948</u> and <u>House Bill 49</u>. Both bill has passed the House chamber.
